Call for two research contracts on the project «Interviews to legal practitioners (judges, prosecutors, lawyers) regarding the implementation of Regulation EU 2018/1805 on the mutual recognition of freezing orders and confiscation in two EU Member States (Lithuania, Sweden)»

The call consists of a comparative evaluation of candidates, based on their curriculum, to award 2 contracts on the project: «Interviews to legal practitioners (judges, prosecutors, lawyers) regarding the implementation of Regulation EU 2018/1805 on the mutual recognition of freezing orders and confiscation orders with internal legal provisions and soft law, in two EU Member States (Lithuania, Sweden)»

The research shall be concluded within 2 months upon the signature of the contract.

#### Activities

The candidate will have to choose one of these activities for the application:

Activity 1: 5 or more interviews to legal practitioners (judges, prosecutors, lawyers) regarding the implementation of Regulation EU 2018/1805 on the mutual recognition of freezing orders and confiscation orders in Lithuania, and compiling of a module with the answers of the interviewed subjects' answers, according to the form provided by the scientific director of the project.

Activity 2: 5 or more interviews to legal practitioners (judges, prosecutors, lawyers) regarding the implementation of Regulation EU 2018/1805 on the mutual recognition of freezing orders and confiscation orders in Sweden, and compiling of a module with the answers of the interviewed subjects' answers, according to the form provided by the scientific director of the project.

#### Admissibility requirements

The following requirements are essential to take part to the selection:

- Master's degree in law;
- Demonstrable knowledge of the language of the country referred to as the object of the contract;
- Demonstrable knowledge of English.

The following requirements are preferential for the selection:

- PhD;

- Previous experience in international research.

#### Compensation

The awardees will receive a lump compensation of € 2.500 each, at the end of their contract.

#### Procedure

The form will be open until midday of 16 December 2022.

The candidate shall fill in the form with the relevant data. If the candidate is not an Italian citizen, the field “Codice fiscale” can be simply filled with: 000000000000000000.

The following documents shall be attached to the form:

- Signed CV
- Valid ID
- Certificate of the Master degree, with evaluation;
- Self-certification of previous experiences such as internships, trainings, publications (title, author/s, publisher, year of publication, abstract), expertise in foreign languages and other relevant experience to the content of the call;
- A signed and date-stamped copy of the privacy informative pursuant to Articles 13 and 14 of the GDPR Regulation, that can be found in attachment to the call (“Allegato 1”)
