The present document in English is to be considered as a summary of the main provisions of the CALL DG/RIC/EST 05/2022 - deadline May 25th 2022, 12:00 pm (CET), which is available in Italian at the following links:

For all legal intents and purposes, the text in Italian is the official text of the call and, in the event of nonconformity with the present document, the former takes precedence over the latter.

Call for five research contracts on the project «Desk research on the implementation of Regulation EU 2018/1805 on the mutual recognition of freezing orders and confiscation orders with internal legal provisions and soft law, regarding five EU Member States (Estonia, Finland, Lithuania, Portugal, Sweden) and brief recapitulation of the fundamental traits of their criminal justice systems»

The call consists of a comparative evaluation of candidates, based on their curriculum, to award 5 research contracts on the project: «Desk research on the implementation of Regulation EU 2018/1805 on the mutual recognition of freezing orders and confiscation orders with internal legal provisions and soft law, regarding five EU Member States (Estonia, Finland, Lithuania, Portugal, Sweden) and brief recapitulation of the fundamental traits of their criminal justice systems».

The research shall be concluded within 3 months upon the signature of the contract.

Activities

The candidate will have to choose one of these activities for the application:

Activity 1: research on national hard and soft law implementing Regulation EU 2018/1805 in Portugal and drafting of a national report on the subject, adding a brief recapitulation of the fundamental traits of their criminal justice systems following a template that will be made available by the Scientific tutor of the project.

Activity 2: research on national hard and soft law implementing Regulation EU 2018/1805 in Estonia and drafting of a national report on the subject, adding a brief recapitulation of the fundamental traits of their criminal justice systems following a template that will be made available by the Scientific Manager of the project.

Activity 3: research on national hard and soft law implementing Regulation EU 2018/1805 in Lithuania and drafting of a national report on the subject, adding a brief recapitulation of the fundamental traits of their criminal justice systems following a template that will be made available by the Scientific Manager of the project.

Activity 4: research on national hard and soft law implementing Regulation EU 2018/1805 in Sweden and drafting of a national report on the subject, adding a brief recapitulation of the fundamental traits of their criminal justice systems following a template that will be made available by the Scientific Manager of the project.

Activity 5: research on national hard and soft law implementing Regulation EU 2018/1805 in Finland and drafting of a national report on the subject, adding a brief recapitulation of the fundamental traits of their criminal justice systems following a template that will be made available by the Scientific Manager of the project.

Admissibility requirements

The following requirements are essential to take part to the selection:

- Master's degree in law;
- Demonstrable knowledge of the language of the country referred to as the object of the contract;
- Demonstrable knowledge of English.

The following requirements are preferential for the selection:

- PhD;
- Previous experience in international research.

Compensation

The awardees will receive a lump compensation of € 2.500 each, at the end of their contract.
