CURRICULUM VITAE

Silvia Ferreri is full professor of comparative law at the Law Department, University of Turin, Italy (where she graduated in 1977).

Previously she held academic positions, in the progress of her career, at the Università Bocconi, in Milan (in the 1980s), in Venice (Università Ca' Foscari, in 1996-97) and then in Alessandria (Università Amedeo Avogadro).

Her major fields of interest are the interaction between uniform laws drafted at international level and the national legal order, especially on issues of private law; the law of property, particularly from the perspective of remedies to recover personal property, in light of comparisons between civil and common law; the law of contract, with special regard to its interpretation and the sale of goods.

She has published several books in Italian: the main ones are concerned with the process of unification of law (*Le fonti a produzione non nazionale*, in *Le fonti a produzione non nazionale*, in PIZZORUSSO, FERRERI, *Le fonti del diritto italiano*, *Le Fonti Scritte, Trattato di diritto civile* dir. by R. Sacco, Turin, 1998), the law of property (*Le azioni reipersecutorie in diritto comparato*, Milano, Giuffré, 1988); the law of contract (*Il giudice italiano e l'interpretazione del contratto internazionale*, Padua, 2000; *La vendita*, Turin, 2006). She has cooperated in many international researches, notably in connection with the process of integration within the European Union (Acquis group. org). She has been general reporter to the XVIII Congress of the International Academy of Comparative Law (Washington, 2010) on the subject of “Complexity of transnational sources”. She has been awarded by the European Commission an international study on “quality control of documents in international organizations and public administrations”.

She has taught in Louisiana as visiting professor at Louisiana State University Law School (2008) and in London within the CTLS, the international program run by Georgetown University together with several other universities belonging to different countries. She has taught at McGill University (Montreal) and at the master program of the IALS (Institute of Advanced Legal Studies) in London. She is a member of the SIRD (Società Italiana Ricerca in Diritto Comparato), of the French-based Association Henri Capitant des amis de la culture française as well as member of the International Academy of Comparative Law.
